- ✓ Pay quarterly dues promptly. Any member failing to pay fees and dues by the prescribed time (payable starting January 1, April 1, July 1, October 1, and delinquent after the 30th of the same month) shall be notified in writing by the Treasurer via email or US Mail at the member's last known address. If the fees and dues are not paid by the 15th of February, May, August, or November, said membership shall automatically terminate. The Board of Directors reserves the right to waive termination of membership for good cause.
- ✓ The cause for non-payment is presented to any Club Board Member by the member.
- ✓ Be encouraged to make a minimum contribution of \$25 per quarter to the Rotary Foundation. This optional contribution is noted in the quarterly dues invoice for convenience purposes.
